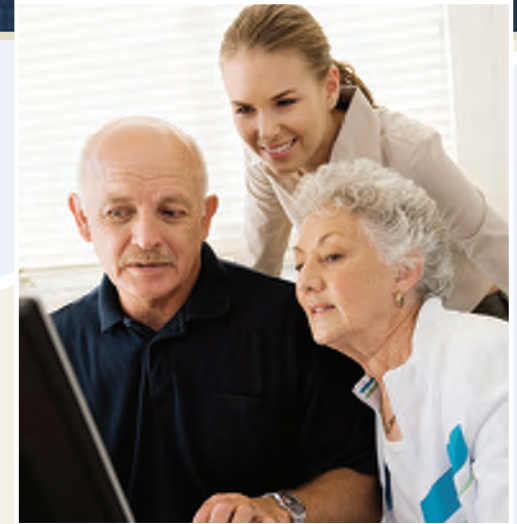
Caring for a loved one can be a daunting task. Knowing where to start and where to get comprehensive information is even harder.
